# COWAN INSURANCE COLUMN

## We have a new Cowan Insurance Column in our Newsletter!

### **Dear Carla:**

*What's the difference between "agreed value" and "actual cash value" policies?*

### **Dear CPS Member:**

"Agreed value" means that you and your insurance company "agree" on the value your boat is insured for. In the event of a total loss, you will receive the full stated amount, with no depreciation. "Actual cash value" means you will only receive the amount your boat is worth at the time of the loss, including depreciation. For example, if your boat is insured for \$100,000 and your boat sinks, an "agreed value" policy will pay out the full \$100,000. In contrast, an "actual cash value" policy will pay out \$100,000 less depreciation.

Cowan policies are always "agreed value" policies. Although "agreed value" policies may cost a little more upfront, it is well worth the extra dollars.

### **Dear Carla:**

*What is commercial towing?*

### **Dear CPS Member:**

Commercial towing is coverage, similar to CAA for your car. It covers your boat or trailer if voluntary help is unavailable and you need commercial assistance. For example, if your engine fails or you run out of gas, towing your boat to the nearest repair facility or delivering gas (excluding cost of gas) is covered. If you are towing your boat and trailer on land and you have a car accident, the towing of your boat and trailer is also covered.

Cowan only charges \$15.00/year for commercial towing. It covers up to \$500.00 per occurrence with no deductible.

# MS Freedom of the Seas

The first time I saw her it was from a window in the shuttle that brought us from Miami airport. She was at the wharf, her great length and towering height were something that I could not have envisioned. Later I would be able to see her from a high vantage point in the old fort in St. Juan where the beautiful architecture of the super structure could be better viewed.

The structure at the bow is raked aft to the bridge and atop the bridge there are three disc shaped glazed levels stacked aft in stagger fashion. She presented a very clean and interesting exterior which we learned was not only beautiful but also very functional. Some of her stats may be of interest and I list them without comment:

**Built** Finland 2006 - **Registry** Bahamas -

**Took** 27 months to build

**Tonnage** 160,000 tons

- **Length** 1,112 feet - **Draught** 28 feet - **Beam** 184 feet

**Height** waterline to top of funnel 208 feet

**Passenger capacity** 3,634

**Crew size** 1,360 included—200 cooks

**Elevators** 12 - **Decks** 15 - **Pools** 3 - **Hot tubs** 6 - **Bars** 12

**Rudder** none - **Propeller pods** that turn 360 degrees

**Horses** 57,000 - **Cruising speed** 21.6 knots

Accessible via a glass foot bridge there was a promenade, which held shops, boutiques, coffee and pizza parlours etc. It was like a high end shopping mall and about the length of a decent city block - 440 feet. Other amenities were an ice skating rink with skates available, a theatre, a rock climbing wall and spas. There were many attractions for young children and teens.

We were fortunate in having a stateroom with a balcony at the stern which meant that there was very little pedestrian traffic close to us and we had view of the



ship's wake which churned the Caribbean water from bright sunlit white through some gorgeous iridescent blues and greens.

The state room was well appointed with a king size bed, a three piece bath, refrigerator, flat screen TV, ample closet, safe, and a desk and chair. The 10X16 balcony deck came with two lounges, two chairs and a table.

Although we experienced force 10 Beaufort with the wind blowing the spray from the crests of the waves the ship was very stable and we were very comfortable. So stable was she that a wine glass on a shelf did not move. The motion however did encourage much napping, so much so that a record of four was achieved on one particular day by our commander.

Food, well everyone who cruises raves about the food and for good reason so all I will say is that if you intend to go, practice eating. Service was to me at least, beyond even minor reproach; the cosmopolitan crew bent over backward and jumped through hoops always cheerfully and often with good humour. They were to a man and woman as accommodating as even an old curmudgeon like me would be hard pressed to decry.

Many of the crew were from less fortunate parts of this world and were aboard for nine months during



which they worked every day and often twelve or fourteen hours. Then it is two months off and back to the ship for another nine.

We disembarked at three islands in the eastern Caribbean but instead of going to the watch, ring and hat show we rented a car and drove to beaches and relaxed.

Upon receiving the keys to our much scratched and dented vehicle in St. Thomas we made the surprising observation that every one was driving on the wrong side of the road. We had no option so joined the crowd. The maximum speed was only 35 MPH but the hills and hairpins produced from our commander on several occasions, my name in full; the last syllable being a loud plaintive wail! I believe she may have found religion in those hills!

In closing I will state that the ship and her crew were deserving of all the superlatives and we are looking forward to our next cruise.

Space does not allow for some suggestions on cruising but if you are considering your first one, talk at length to an experienced cruiser. We learned a lot from fellow passengers and even from the crew; things that made our passage more enjoyable and that saved us good sums.

But all you sailors know that that is what boating is all about. Don't you?

The 2008-09 training year has been very productive and busy.

We have 30 Boating Students eligible to write on April 7. In the fall of 2008 a GPS class of 6 students wrote and passed the course. This group was instructed by our **Des Wood** who passed away before the course was completed Gary Young instructed the remaining lessons.

A second **GPS course** of eight students instructed by Glen Carruthers was done in February 2009 and all were successful.

A **Boat Pro course** took place in February. 8 Students wrote and passed the boating proficiency test to obtain the pleasure craft operator card.

On April 2, 2009, 19 of the Boating class students wrote the accredited version of the boating proficiency test and all succeeded.

19 attended the VHF seminars and all were successful in getting certification for the marine radio telephone.

The **Seamanship course** is still underway and the exam will be written in April.

There will be another **VHF course** on April 19/09 and 11 participants have signed up for it to date.

I would like to thank the assistant training officer Glen Carruthers and also the proctors and instructors who came out all year long with little argument. It has been a learning experience for both Glen and me I hope we have fulfilled our job expectations properly.
