

# **GABRIOLA ISLAND SQUADRON**

## **Minutes of the Bridge Meeting**

**Held on January 26<sup>th</sup>, 2023**

The Meeting was held both at a physical location (Commander's residence on Gabriola) and by GoToMeeting.

**Call to Order:** 15:05 by Commander Jean-Pierre Van Praet.

**Minutes of the previous meeting** of November 24<sup>th</sup>, 2022: moved by Agathe, seconded by Elaine, that the Minutes be accepted. Approved.

**Reports:** Reports submitted by Don Butt (Scuttlebutt and Communications), Li Decosas (PRO), Jude Briscoe (Financial), Elaine Pearce (Membership), J-P Van Praet (Commander) and Nigel Wells (Webmaster) are on our microsite.

### **Educational**

Agathe explained the Education Department's tentative programme for courses and seminars. After discussion it was agreed with full consensus that these would mostly be run in the Gabriola Recreation Society (GRS) classroom at the Gabriola Elementary School. GRS would like to collaborate in the planning of the courses and would include them in their advertising online and in the Sounder. The Squadron would be able to use Mike's TV for presenting, and it and other materials might be able to be stored in the classroom for the duration of the courses. There would be a requirement that at least one person present at each event should have undergone a Criminal Records Check, but Agathe would find out and report back.

4 seminars: "Marine Electrical Maintenance" on March 1<sup>st</sup>, presented by Nigel using CPS-ECP materials, which the Squadron would purchase

"Knots for sailing and docking" on March 8<sup>th</sup>, presented by Sean

"Electronic Marine Navigation" on March 15<sup>th</sup>, presented by Nigel, using Boating 2 material and simulations

"Weather" presented by John Bullas on May 17<sup>th</sup>, but with Agathe and Nigel present in a supporting role.

It is proposed to run an in-person Boating 2 course. This course will take 3 sessions – March 22<sup>nd</sup>, March 29<sup>th</sup> and April 12<sup>th</sup>.

It is also proposed to run an in-person ROC(M) course over two sessions - April 19<sup>th</sup> and 26<sup>th</sup>, with the exam on the 26<sup>th</sup>.

Also there will be a PCOC in-person course over two sessions – May 3<sup>rd</sup> and 10<sup>th</sup>.

A Boating Camp for Youth is planned. It would take place on May 11 and May 12. (2 days). Agathe confirmed that both Thursday May 11<sup>th</sup> and Friday May 12<sup>th</sup> are professional development days for teachers at GES. This would be at the Community Hall, and there was discussion about the use of upstairs in the Hall, to give more bad-weather flexibility.

Don requested that he be given details of the various dates and times so that he could attend and take some photographs.

### **Advertising Courses and Seminars**

Li reported on the relatively poor condition of the Sandwich Boards and asked whether she should investigate the construction of some new ones. It was decided that they were of good construction, and worth servicing, which Nigel agreed to do. There was discussion of the merits of the Sounder adverts, of inserts and Facebook ads. It was pointed out that the collaboration with GRS would allow wider advertising on all platforms and that we could use our Facebook page to advertise further.

### **Membership**

Elaine gave details about issues that she had with the membership status of three members of the Bridge. One was resolved after communication with National and two remained outstanding. After some discussion about member benefits Elaine committed to confirm the nature of the benefits at various local businesses as these are the most relevant to our membership.

### **Social events winter and spring**

Following discussion of the desirability of having an indoor social event it was decided that we would delay a decision until later in the spring, when an outdoor event would be more attractive.

### **Financial**

Jean-Pierre described the Squadron's relatively healthy financial position, though there was some question about possible outstanding payments to National, as well as their slowness in making payments for expenses. Nigel reminded the meeting of the importance of sponsorship funds as part of our income stream, and Li was commended for her efforts to continue and expand them. It was noted that most of the \$1000 fee for Agathe's teaching of the ROC(M) course at the Global ROAMS School in Qualicum Beach in February would be taken up in exam fees, so there would be little net income from that source. A motion was proposed by Nigel, seconded by Don that **"the Squadron offer support for Agathe's travel expenses at standard CPS-ECP rates"**. Passed unanimously.

### **Hakai Light Trap project at Page's dock**

Jean-Pierre reported that he had been asked by Heather Earle whether we would be prepared to take the lead on the Light Trap project. He was prepared to co-ordinate again and felt that there was real enthusiasm for the project among the volunteers. There was a consensus that we should continue and that the project was a good way of increasing our exposure to the island community. Jean-Pierre will communicate that to Heather and will contact the existing volunteers.

**Nominating Committee for Bridge 2023-2024**

Jean-Pierre advised that the Committee is making progress.
